Update: India Impact Investment Conclave 2016

Dear Members,

- **Conclave Design:** Our conclave has two parts, a 1-day immersive field trip to social enterprises followed by 1.5-days conclave in New Delhi. - **Venue:** The conclave will take place at TERI Retreat on Gurgaon-Faridabad highway. The three Fireside Chats will be held at Vivanta by Taj, MG Road, Bangalore; Taj Santa Cruz, Mumbai; and, Vivanta by Taj, Gurgaon.
